IMPORTANT: Please ensure you have read and signed the user information and disclaimer before use.

The following information has been compiled for your safety and comfort whilst using the Fordhall Tramper, please read the following information carefully, if there is anything you do not understand, please ask a member of the Fordhall team who will be happy to provide you with further information.

TERMS AND CONDITIONS - SAFETY

1. Visitors use the Tramper at their own risk. Fordhall Community Land Initiative cannot be held responsible or liable for any incident, accident or injury that occurs as a result of using the Tramper.
2. The Tramper can only be used by people aged 18+, under 20 stone, unless otherwise agreed with management.
3. **You agree that you are using the Tramper at your own risk, and will remain on the recommended route 'Charlotte's walk' (see separate map) for safe usage around the farm.**

TERMS AND CONDITIONS – GENERAL

1. The Tramper is for use by the person signing this form only. They must not allow any other visitor to use the Tramper, or carry any child or person anywhere on the Tramper with them.
2. Failure to comply with any of the terms and conditions and operating procedures may result in you being asked to leave the farm.
3. You agree to complete a short test loop within Cottage Field (see map) to ensure comfort with operating the Tramper before departing for a full route.
4. Users must be accompanied when using the Tramper by another member within their party.

OPERATING THE TRAMPER: DO AND DON'TS

- DO ensure the Tramper is switched off at the key when getting on or off the Tramper.
- DO keep your arms, legs and feet within the confines of the Tramper when moving.
- DO ensure the seat is in the locked position when getting on or off the Tramper, before putting weight on the armrests.
- DO keep both hands on the steering tiller when moving.
- DO notify staff if you notice anything unusual when operating the Tramper.
- DO let go of the lever on the steering tiller if you get into any difficulties- THIS WILL STOP THE TRAMPER.
- DON'T use the Tramper if you are unsure of your competency or physical ability to use it safely.**
- DON'T allow any other visitor to use the Tramper, or to ride on the Tramper with you.
- DON'T hold onto the steering tiller when getting on or off the Tramper.
- DON'T allow another visitor to handle the steering tiller when you are in motion.
- DON'T go faster than walking speed when moving around the park.

The information above has been compiled for your safety and to ensure the safety of other visitors to the farm. By signing the declaration overleaf, you are confirming that you have read and understand and agree to the terms, conditions and safe use of the vehicle as listed above. Please note should you be responsible for any incident of any nature on the farm we will have no choice but to ask for the immediate return of the Tramper.
